
AGREEMENT


Contract Agreement for Project Management Agency for Deen Dayal Upadhyaya Gram Jyoti Jojna (DDUGJY) and Integrated Power Development Scheme (IPDS) at Madhyanchal Vidyut Vitran Nigam Limited (MVVNL) against tender specification no. MEDCO/1503/R-APDRP B/2015

THIS AGREEMENT is made on 14th day of December 2015 between M/s Medhaj Techno Concept Pvt. Ltd., having its registered office at CP-150, Sector D-1, Aashiana, Kanpur Road, Lucknow- 226012 (hereinafter referred to as "The Consultant") of the one part and the Madhyanchal Vidyut Vitran Nigam Limited, having its office at 4A, Gokhale Marg, Lucknow- 226001 (hereinafter called "The Purchaser") of the other part.

Saxena, Superintending Engineer (RAPDRP B), MVVNL, Lucknow (The Engineer of the Purchaser) on behalf of the Purchaser all of which are deemed to form part of this contract as through separately set out herein and are included in the expression 'Contract' wherever here in used.

AND WHEREAS the purchaser accepted the Bid of the Consultant for the provisions and execution of the said works for the sum of 0.419% (Zero Point Four One Nine Percent) of approved DDUGJY DPR cost and 0.3947% (Zero Point Three Nine Four Seven Percent) of approved IPDS DPR cost and Service Tax to be paid extra as applicable, as per contract upon the terms and subject to the conditions hereinafter mentioned.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Contract referred to.
2. The following documents (collectively referred to as "Contract Documents") shall be deemed to form and be read and construed as part of this Agreement viz:

 - ii). Acceptance of LOI vide letter no.MTCPL/MVVNL/PMA/15-16/2952 dated 16.11.2015;
 - iii). Discount letter no.MTCPL/MVVNL/PMA/15-16/2832 dated 02.11.2015;
 - iv). Bid submitted vide offer letter no.MTCPL/MVVNL/PMC/15-16/220N dated 06.10.2015;
 - v). Bid document/ Tender Specification no. MEDCO/1503/R-APDRP B/2015;
 - vi). 'Form-A' of UPPCL/MVVNL;

In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.

3. In consideration of the payment to be made by the Purchaser to the Contactor as indicated in this Agreement (As per LOI), the Consultant hereby covenants with the Purchaser to provide the Related Services and to remedy defects therein in conformity in all respects with the Provisions of the Contract.
4. The Purchaser hereby covenant to pay the Consultant in consideration of the provision of the Goods and Related Services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the Contract.
