Sir,

Pay & Accounts Office, Ministry of Power (MoP) has observed that implementation of PFMS at the level of Utilities is not satisfactory and very few Utilities are filing their expenditure details in the EAT (Expenditure, Advance and Transfer) module of PFMS. In the absence of use of PFMS by Utilities, it is not possible to monitor actual utilization of funds upto last level. Further, the use of PFMS by implementing agency is being monitored at the highest level of Government of India. Therefore, you are requested to file all expenditure details under IPDS in the PFMS system before 31.03.2017.

In view of the above and to hand-hold the Utilities in implementation of PFMS upto Vendor level, Pay & Account Office, MoP has arranged a workshop/ training programme on PFMS implementation at Patna from 16-03-2017 to 17-03-2017 for the Utilities of Bihar, Jharkhand, West Bengal, Madhya Pradesh and Chhattisgarh. Concerned officials from these Utilities are requested to attend the proposed workshop/ training alongwith necessary details viz. login ID, password of PFMS A/c, cheque details, invoice nos. as well as data related to IPDS expenditures for compulsory spot filing the same in the PFMS system.

Moreover, Utilities are requested to indicate details (name, designation, mobile no. & e-mail ID) of the concerned officials for the proposed training immediately on power.itcell@gmail.com and fahad_rahman@pfcindia.com for making necessary arrangements for the workshop/ training programme.

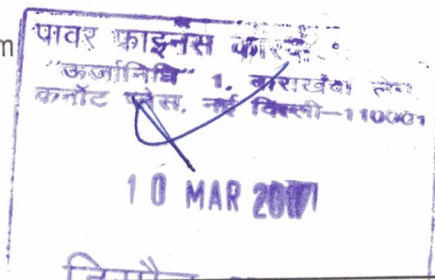
